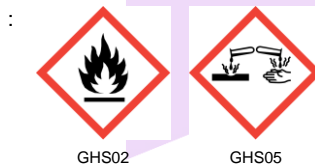

## SECTION 4: First aid measures

### 4.1. Description of first aid measures

First-aid measures general : Remove contaminated clothing and shoes. In case of accident or if you feel unwell, seek medical advice immediately (show the label where possible). ## SECTION 5: Firefighting measures

### 5.1. Extinguishing media

Suitable extinguishing media : Alcohol-resistant foam. Carbon dioxide. Dry chemical. Use of high expansion foam (100:1) is recommended to cover flames.

Unsuitable extinguishing media : Water.

### 5.2. Special hazards arising from the substance or mixture

Fire hazard : Flammable liquid and vapor. Irritating fumes of hydrochloric acid and organic acid vapors may develop when material is exposed to water or open flame.

### 5.3. Advice for firefighters

Firefighting instructions : Exercise caution when fighting any chemical fire. Use only dry media to extinguish flames. Water spray or fog should only be used to knock down hydrogen chloride vapors in areas downwind from the fire.

Protection during firefighting : Do not enter fire area without proper protective equipment, including respiratory protection. Avoid all eye and skin contact and do not breathe vapor and mist.

#### 6.1. Personal precautions, protective equipment and emergency procedures
