5.2. Special hazards arising from the substance or mixture

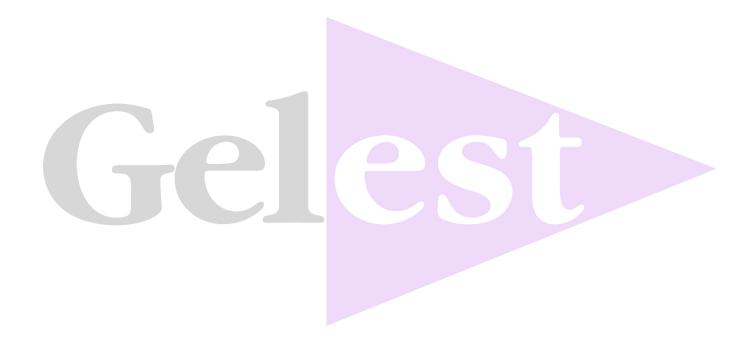
